This is a part-time to full-time position, with a minimum commitment of 15 direct service hours per week for in-person therapy at our Chicago Old Irving Park location and telehealth remotely. Candidates with a desire to build a caseload to full-time employment with a minimum of 25 direct service hours per week are encouraged to apply.

- Fully licensed LCPC/LCSW in preferred, LPC/LSW and eligible to be fully licensed in Illinois required
- Two years + post-graduate work in the field
- Comfortable and familiar with working with diverse populations
- Available at least 15 direct service hours per week, including at least one weekend day.

## Compensation:

Compensation is based on licensure, experience, and caseload size.

Compensation includes an hourly rate for billable direct service/clinical hours (\$42 - \$52/hour starting part-time rate), plus an hourly rate for non-billable administrative hours (\$20/hour).
